- Driver and Rider must be 16 years of age or older
- Wheels may be no larger than 26 inches
- Bathtub must have brakes and steering
- There must be at least one rider (helmet provided)
- No more than one person can push (closed toe shoes required)
- There is no limit to the number of wheels
- Businesses may advertise on the sides of their bathtub
- Tub must be under control of a pusher and may not be released until tub has come to a complete stop
- Crossing the line during the races will result in disqualification of that heat
